C. Review LIMRiCC Health Insurance Rates for 2020

Director Cole reviewed the health insurance rates for 2020. Rates on the plan are increasing by 5% which is the largest increase we have absorbed since LIMRiCC became self-insured in 2016. The increase in premiums will amount to \$691.20 for the library in 2020. The increase has already been factored into the budget.
