### LIBRARY DIRECTOR'S REPORT

Director Cole reported that she and President Peterson had met with Sydney Fitch of Verde Energy Efficiency Experts to discuss their proposal to relamp the second floor with LED light fixtures. The savings through the ComEd rebate program would be substantial, but we are waiting to see what the rebate structure for 2020 will be as it does change from year to year. We hope to have this information for the December meeting to review the proposal further. In the meantime, Verde has installed two LED fixtures in the women's room on the 2<sup>nd</sup> floor so we can get an idea of what the fixtures would look like.
